Board of Directors' Meeting

October 17, 2019

The Marion County Chamber of Commerce Board of Directors met at the Western Sizzlin at noon on October 17, 2019. Board members in attendance were Kathie Tierney, Shelby Potterfield, Vicki Messer, and Donna Sartin.

(Please note that a quorum of board members was not in attendance. In the absence of a quorum, a request for an e-vote for any motions made during this meeting will be sent to all board members.)

President Kathie Tierney called the meeting to order and recognized those in attendance.

Approval of Minutes:

A motion was made by Vicki Messer and seconded by Shelby Potterfield to approve the minutes from the September 19, 2019 board meeting. E-vote will be requested. Minutes are on file in the chamber office and will be posted on the chamber's website.

Financial Report:

Mayor’s Report:

South Pittsburg City Administrator, Gene Vess

The City of South Pittsburg will host downtown Trunk ‘r Treat on Halloween night, beginning at 6:00 PM CDT. There will also be a Veteran’s Day Parade on Saturday, 11/9/19, at 10:00 AM and a Christmas Parade on December 7th, at 10:00 AM CST.

Mr. Vess stressed the importance of counting all South Pittsburg residents in the 2020 Census. According to Mr. Vess, the 2010 census resulted in an undercounting of residents; therefore, the 2020 census is an opportunity to provide a more accurate count which will impact money and programs for the next ten years. “The federal government bases a large amount of spending decisions, including on highways and low-income programs, on census data.” (Rich Pedroncelli/Associated Press)

Marion County Mayor David Jackson

Mayor Jackson reiterated the importance of an accurate census head count not just for every municipality/community but also for the county as a whole.

Mayor Jackson reminded us that the burn ban is still in effect in Marion County until further notice.

Mayor Jackson explained that there has been a delay in sending out Marion County property tax notices this year but that they should be mailed to property owners soon.

On November 9th there will be a confiscated vehicle sale at the Lawson Building at 300 Ridley Drive in Jasper. On November 11th there will be a sale of delinquent tax property.

Marion County has been awarded a ThreeStar Grant for \$25,000 to be used for workforce development.

Representatives from “Project Outback” visited the New Hope area on October 16th. No commitment at this time.

“Project Water” has selected Marion County as the site for a new business. Announcement is expected the first or second week in November.

Miscellaneous

Among information shared by Shelby Potterfield is that SVEConnect has now expanded into the Whitwell, Victoria and Griffith’s Creek area. On October 24th at 6:00 PM, there will be a South Pittsburg Mountain Fiber Update Meeting at Orme Mountain Church of God. All interested persons are invited.

Cody Fox announced that Tennessee Tub Factory had recently bought Baja Spa company and will be incorporating their products with existing Fox Brand Products.

Josh Brown with TN Small Business Development announced an upcoming training session for businesses interested in exporting goods and services. “Export Boot Camp” is scheduled for October 24th from 9:00 AM EDT until 11:00 AM at the Hamilton County Incubator, 100 Cherokee Blvd in Chattanooga. Mr. Brown will send information to the chamber office to be shared through the chamber’s email distribution list.

Jake Wilbanks announced that the new Fast Pace Urgent Care Clinic in Jasper will have a grand opening on December 6th. Details will be shared via the chamber’s email distribution list.
